Description:

Davimet™ Multivitamin is a grape flavor chewable tablet, recommended to supply significant amounts of vitamins A, C, D, E, thiamine, riboflavin, niacin, vitamin B6, vitamin B12, and folate to supplement the diet, and to help assure that nutritional deficiencies of these vitamins will not develop. Folate is effective in the treatment of megaloblastic anemias due to a deficiency of folate (as may be seen in tropical or non-tropical sprue) and in anemias of nutritional origin, pregnancy, infancy, or childhood.

Phenylketonurics: Phenylalanine 3.0 mg Per Tablet.

Indications and Usage: Davimet™ Multivitamin Chewable Tablets are indicated to provide significant amounts of Vitamins A, C, D, E, thiamine, riboflavin, niacin, vitamin B₆, vitamin B₁₂, and folate to supplement the diet, and to help assure that nutritional deficiencies of these vitamins will not develop.

Contraindications: This product is contraindicated in patients with a known hypersensitivity to any of the ingredients.

Precautions: Folate in doses above 0.1 mg daily may obscure pernicious anemia, in that hematologic remission can occur while neurological manifestations remain progressive. There is a potential danger in administering folate to patients with undiagnosed anemia, since folate may obscure the diagnosis of pernicious anemia by alleviating the hematologic manifestations of the disease while allowing the neurologic complications to progress. This may result in severe nervous system damage before the correct diagnosis is made. Adequate doses of vitamin B₁₂ may prevent, halt, or improve the neurologic changes caused by pernicious anemia. The patient's medical conditions and consumption of other drugs, herbs, and/or supplements should be considered.

Adverse Reactions:

Folate: Allergic sensitization has been reported following both oral and parenteral administration of folate. Adverse reactions have been reported with specific vitamins and minerals but generally at levels substantially higher than those contained herein. However, allergic and idiosyncratic reactions are possible at lower levels.

Dosage and Administration: One (1) **Davimet™ Multivitamin Chewable Tablets** daily, to be dissolved in the mouth or chewed before swallowing, between meals or as directed by a licensed healthcare practitioner.

How Supplied:

Davimet™ Multivitamin Chewable Tablets are light purple with speckles, grape flavor, un-scored, round tablets. Available on prescription only in bottle of 30 tablets – NDC 59088-695-54. Dispense in a tight, light resistant container with a child resistant closure as defined in the USP/NF. All prescription substitutions using this product shall be pursuant to state statutes as applicable. This is not an Orange Book product.

Storage:

Store at 20° to 25°C (68° to 77°F)

Do not use if bottle seal is broken.
